#### A-1 “I Feel You: Understanding Empathy and The Phenomenon Known as Empathy Gap”

#### A-2 “Human Trafficking; The Risk within Child Welfare”

This training will provide an understanding of human trafficking. Attendees will be able to identify indicators that someone might be experiencing human trafficking and how to report the situation to the appropriate authority. We will review risk factors as well as high risk populations.

#### A-3 “Racism as a Toxic Stressor for Families: What Can Home Visitors Do About it?”

Information on different types of stress, how racism can be viewed within the lens of toxic stress, as well as some relationship-based strategies for home visitors in supporting families will be considered. Recent research on toxic stress, inequity, racism, and early childhood development will be used to support understanding of concepts. Home visitors will be asked to consider the role their relationships play in supporting children and families experiencing racism and stress.

#### B-1 “Creating a Trauma-Informed Approach for Intimate Partner Violence (IPV) Victim Services”

This workshop will address how communities and programs can become more inclusive of fathers, build upon their strengths, and respond to their needs in culturally responsive ways.

### **C-3 “Plans for Safe Care: Supporting Infants with Prenatal Substance Abuse Exposure and their Families”**

This presentation will address the role of collaborative partners, including home visiting providers, in supporting pregnant and parenting women with substance use disorders and their families and improving maternal, infant and child outcomes. It will also highlight a new technical assistance resource to support state and community agencies in developing and implementing a family-centered, collaborative approach to serving infants with prenatal substance exposure and their families.
